Application for Funding and Support

The Highlander Fund has been established for the purpose of providing supplementary enrichment funding, outside the operating budget of the school, and support for special projects to benefit the students of Northwestern Regional #7 School serving the 7th through 12th grades for the towns of Barkhamsted, Colebrook, New Hartford and Norfolk, Connecticut.

In 2009 representatives of each of the Regional District towns met to form the new fund. The Highlander Fund represents a long term effort to provide a stable source of funding outside the operating budget of the school for enrichment or enhancement programs such as fine and performing arts, academics, clubs and other non-required school programs.

Suggestions for new and creative enrichment projects that we may consider for funding are always welcome. Applications for funding may be sought by anyone provided that the sponsored program will benefit students at Regional and District towns.

When considering an application for funding and support from The Highlander Fund, the following must apply:

- The project/program will benefit the students at Regional #7.
- The project/program is not covered under the normal school operating budget.
- The project/program is not a required school program.
- The project/program for which funding is requested will be self-sustaining (Generally, requests for funds for transportation and/or field trips would not qualify under our bylaws).
